# **DEADLINES/IMPORTANT DATES**

# Monday 28<sup>th</sup> Feb

• Physical distancing measures such as play-pods, and mask wearing, will no longer be required in early learning and care (ELC) and School aged Childcare (SAC) services.

## Tuesday 1<sup>st</sup> March

• The Employment Wages Subsidy Scheme (EWSS) will be reduced from the enhanced rate to the flat rate of €100 per week. It will run until the end of April 2022.

# Monday 14<sup>th</sup> March

• Applications for Linc inclusion coordinators will open. The programme will commence in September 22. It is fully online and 100% funded.

## Changes to NCS Calendar

Its mid-term on 24<sup>th</sup> and 25<sup>th</sup> February, with the option to extend to a five-day break, If you choose to extend your break you need to make changes on your Hive and Pip portal. Please make the changes as quickly as possible so there is no delay to your payments being processed.

### **NCS Non-Term Hours**

If you have children attending your service who require additional hours on NCS over the mid-term break, please submit non term hours for them on the Hive

### It is important to note,

You cannot apply changes to the claim hours, opening hours and service calendar once the return for that week is submitted on the Hive, so check your details carefully.

#### CCSP: Amending Sessions (e.g., a child is moving from part-time to full-time)

If the registration needs updating for the mid-term from part-time to full-time, please input a CCSP Leaver with the date the child is changing attendance. Then create a new application with the updated level of service for the appropriate period. Please see pages 14/15 of the CCSP Registration Guide for further information.

#### **Changes to Covid 19 Restrictions**

On Tuesday 22nd February, Minister for Children, Equality, Disability, Integration and Youth Roderic O'Gorman, issued a statement to ELC and SAC services. From Monday 28th Feb In line with NPHET recommendations, physical distancing measures such as play-pods, and mask wearing, will no longer be required in ELC and SAC services. Due to the fact, that providers will have to transition the services over several weeks, the (EWSS) will remain in place until the end of April at a flat rate of €100 per week as a support to providers.

### Public Holiday March 18th, 2022

This year 2022, a one-off public holiday will occur on Friday March 18<sup>th</sup>. Please do not make any changes to your calendar for 2021 -2022. The department has announced that further information and instructions will be available shortly. There is **no** action required of service providers currently.

### **AIM Level 7 Funding**

Employment Wage Subsidy Scheme subsidy rates are due to reduce from 1st March 2022. Some services have applied for AIM level 7 and have been successful but instead chose to use the EWSS to fund AIM staff as it was more financially advantageous. Now due to the reduction in the EWSS you may choose to do the following:

Service providers who wish to return to the AIM funding must inform Pobal 10 working days in advance of the date they wish AIM Level 7 funding to commence. You do this by raising a request on the Hive.

If you have not submitted an AIM initial application or second year extension application, submit the required application form as soon as possible to avoid a break in funding.


